

परभणीत आरक्षणासाठी आत्महत्या



परभणी (प्रतिनिधी) :
आरक्षणासाठी मराठा तरुणांनी आत्महत्या केल्याच्या घटना तांच्या असतांनाच परभणीत घनगर समाजाला आरक्षण मिळावे म्हणून एका तरुणाने आत्महत्या केल्याची घकादायक घटना घडली आहे. त्यामुळे परभणीत खळबळ उडाली आहे. योगेश राधाकिशन कारके असे या आत्महत्या करणाऱ्या १९ वर्षीय मुलाचे नाव आहे. योगेश हा सेतू तालुक्यातील गोमेवाकडी गावचा रहिवासी आहे. घनगर समाजाला आरक्षण मिळत नसल्याच्या निषेधार्थ आज दुपारी १२.४५ वाजता योगेशने गळफास लावून आत्महत्या केली. त्यामुळे परभणीत खळबळ उडाली.

या घटनेनंतर योगेशच्या कुटुंबीयांनी आणि घनगर समाजातील तरुणांनी योगेशचा मृतदेह पोलीस ठाण्यासमोर ठेवून ठिय्या आंदोलन केले. यावेळी सरकारविरोधात जोरदार घोषणा देण्यात आल्या. या घटनेची माहिती मिळताच जिल्हाधिकाऱ्यांनी तात्काळ घटनास्थळी घाव घेऊन योगेशच्या कुटुंबीयांना १० लाख रुपयांची आर्थिक मदत देण्याची आणि कुटुंबातील एकाला नोकरी देण्याची लेखी आश्वासन दिले. त्यानंतर योगेशच्या कुटुंबीयांनी हे
