

8-month-old Indian-origin boy killed in New York after being struck by van

New York: In an extremely tragic incident, an eight-month-old Indian-origin boy was killed when the stroller he was in was hit by a car as it backed out of a driveway in Queens here. Rodriguez was backing the van out of a driveway last morning when he hit the stroller, knocking Raju out of it. Witnesses said the van kept backing up, running the boy over with the back tire, according to a report in DNAinfo. Raju was rushed to the local hospital immediately but could not be saved. Rodriguez remained on the scene and was taken into custody. Police say he does not have a valid driver's license. Witnesses told PIX11 the mother and baby had just left a nearby deli with a dozen eggs when the mother stopped to fix the blanket on the stroller, stopping behind the van.
