Big Share Services Pvt Ltd** to those Members whose e-mail addresses are registered with the Company, RTA or CDSL / NSDL ("Depositories") as on cut-off date **August 29**, **2025** and also been uploaded on the website of the Company and The Bombay Stock Exchange Ltd.

The Company had published an advertisement about the completion of dispatch of Notice of the 39th Annual General Meeting with other details in **'Business Standard'** (English Daily) and **'Mumbai Lakshadeep'** (Marathi Regional Daily) on 06th September, 2025.

- 2. The Compliance with the provisions of the Companies Act, 2013 and the Rules made thereunder relating to e-Voting (which includes remote e-Voting and the voting through electronic voting system during the AGM) on the resolutions proposed in the Notice calling the 39th Annual General Meeting ("AGM") of the Company was the responsibility of the management.
